## CORPORATE PROFILE OF CPL MEDICAL GROUP LIMITED

#### 1.0 **COMPANY OVERVIEW**

- 1.1 CPL Medical Group Limited was established in 1975 as Continental Pharmaceuticals Limited (CPL), a Member of the CPL Group of Companies, duly incorporated and carrying on business as providers of a wide range of healthcare related services ranging from total overhaul of Medical Facilities, installation of modern diagnostic medical equipment and investigative tools, to supply of medical consumables, with a view to guaranteeing the highest possible level of Clinical Care for efficient running of Hospital Facilities.
- 1.2 The Company was established by an Industrialist, **Prince Albert Adedayo Awofisayo**, with the sole objective of manufacturing of Pharmaceutical Products in Nigeria and ensuring Public Health Facilities, particularly, Tertiary Hospitals in Nigeria, are equipped with the most advanced diagnostic medical equipment available to help improve the provision of basic healthcare related services in Nigeria, as well as curb the menace of Medical Tourism.
- 1.3 The CPL Group is comprised of the following Companies with active participation in various sectors of the Nigerian economy:
  - CPL Industries Limited involved in the Manufacturing and Marketing of Pharmaceuticals, Cosmetics and Personal Care Products.
  - CPL Properties and Investment Limited engaged in the Real Estate and property development.
  - Ore-Irele Oil Palm Company Limited a Joint Venture Company owned by CPL Industries (65%) and the Ondo State Government (15%) with three Local Communities (10%), engaged in Agriculture / palm oil production and sale.
  - CPL Agric & Investments Limited fully engaged in the Agricultural Sector.

• Ikorodu Bricks & Clay Products Limited – in the business of clay bricks production for mass housing development and production of ceramic tiles.

#### 6.0 MILESTONE ACHIEVEMENTS

- 6.1 The CPL Group being the pioneer indigenous Medical Equipment Installation and supply Company in Nigeria, successfully executed her first major Healthcare Contract in 1980 when the Company supplied X-Ray Machines to the General Hospital, Kebbi, in the then Sokoto State.
- 6.2 In the year 2002, CPL Medical Group, together with its Technical Partner, VAMED Engineering GmbH & Co of Vienna, Austria, were commissioned by the Federal Government of Nigeria, to Refurbish and Modernize Eight (8) Federal Teaching Hospitals in the Country. The Project, which was on a Turnkey Basis vide direct procurement, was successfully executed and commissioned by the President between 2006 and 2007.
  - The Project was implemented to ensure effective provision of healthcare related services in the different Clinical areas of the Teaching Hospitals viz: Surgery (Theatre, O & G), Radiology (Diagnosis and Therapy), Anesthesia and Intensive care, Laboratory Services, Accident and Emergency (Casualty, Orthopedics), Other departments (Medicine, Pediatrics, ENT, Ophthalmology, Dentistry, Pharmacy.
  - Impressed with the satisfactory delivery of Phase I, approval for commencement of Phase II comprising six (6) Federal Teaching Hospitals was given in 2006 by the Federal Government and the Company commenced implementation together with its Technical Partner, VAMED Engineering GmbH & Co of Vienna, Austria. Phase II was also successfully completed and commissioned by the Federal Government.

• The company is currently working with the Federal Government of Nigeria through the Federal Ministry of Health for the phase Ill on PPP (Public Private Partnership) basis.

- 6.3 The Company also oversaw the following Hospital construction / Rehabilitation Projects in various States of the Federation:
  - 2003 CPL Medical Group Limited and its Technical Partner executed a contract to supply and install Medical Equipment at the Niger Delta University Teaching Hospital, Amassoma, Bayelsa State.
  - 2005 CPL Medical Group Limited won and executed the Contract to supply and Install Medical Equipment to New Lokoja General Hospital, Lokoja, Kogi State. The contract was awarded by the Kogi State Government.
  - 2005 to 2007 The Company together with VAMED carried out Construction, equipping and provision of training for 200 Bed Stella Obasanjo Women and Children Hospital, Edo State.
  - 2007 to 2008 In partnership with VAMED, CPL carried out the rehabilitation of General Hospitals in 9 Local Government Areas, as well as rehabilitation of Bauchi Specialist Hospital, Bauchi State.
  - 2009 Also in partnership with VAMED, CPL carried out the rehabilitation of the 200 Bed Rasheed Shekoni General Hospital, Dutse, Jigawa State.

#### 6.4 **COMMENCEMENT OF PHASE 3**

After the successful completion of the 1<sup>st</sup> and 2<sup>nd</sup> Phases of the Ongoing Project, the Presidency of the Federal Government of Nigeria approved the commencement of the process leading up to implementation of the 3<sup>rd</sup> Phases of the Ongoing Health Project under a Public Private Partnership (PPP) Model, in 2014.

The scope of the  $3^{rd}$  Phase Project is as follows:

• Rehabilitation / Revamping of the 14 Teaching Hospitals already Rehabilitated under Phases 1 and 2.

- Rehabilitation / Revamping of the 8 new Teaching Hospitals (*National* Hospital, Abuja, Federal Teaching Hospital, Abakaliki, University of Abuja Teaching Hospital, Gwagwalada, Abubakar Tafawa Balewa University Teaching Hospital, Bauchi, University of Uyo, Federal Teaching Hospital, Gombe, Federal Teaching Hospital, Ido-Ekiti and Specialist Teaching Hospital, Irrua) established by the Federal Government of Nigeria.
- Construction and Equipping of a New State of the Art 500 Bed Federal Centre of Medical Excellence in Abuja, and
- Management of the 22Teaching Hospitals and the 500 Bed Hospital.

#### 7.0 MANAGEMENT TEAM

- 7.1 The activities of the Company are coordinated by a competent Board of Directors comprised of eminent Nigerians from various walks of life, whose responsibility it is to formulate the policy directions of the CPL Medical Group Limited.

He is a renowned Industrialist, and founder of Continental Pharmaceuticals Limited (CPL) established in 1975, a Company which has today become popularly known as CPL Industries Limited. Continental Pharmaceuticals Limited was one of the first generation indigenous pharmaceutical products manufacturing Industries in Nigeria.

In 1980, Prince Albert Awofisayo as Chairman, initiated medical equipment supplies and hospital refurbishment, rehabilitation and modernization services to expand the healthcare business activities of CPL.

In 2002, a special Proposal aimed at revamping our Tertiary Health Care Sector, submitted to the Federal Government of Nigeria by CPL Medical Group, signed by its Chairman, Prince Albert Awofisayo, was adopted and approved in preference to over eleven (11) other competitive Proposals from both and local and international Medical Facilities development Companies, for the refurbishment, rehabilitation, reequipping and modernization of eight (8) Federal Teaching Hospitals under Phase I of the FGN/CPL Special Presidential Intervention Projects in the Tertiary Health Sector on turnkey basis.

Upon successful commissioning and satisfactory inspection of Phase I, the Federal Government of Nigeria approved the commencement of Phase II, and six (6) Federal Teaching Hospitals were approved for refurbishment, rehabilitation, reequipping and modernization under the same FGN/CPL Special Presidential Intervention Projects in the Tertiary Health Sector.

Under the watch of Prince Albert Awofisayo, Phase I and Phase II of the Health Project was successfully completed.

In 2011, the 3<sup>rd</sup> Phase Proposal, signed by the CPL Medical Group Chairman, Prince Albert Awofisayo, was submitted to the Federal Government of Nigeria. Approval for commencement of the 3<sup>rd</sup> Phase was given by the Federal Government of Nigeria, led by then President Goodluck Jonathan, who gave a nod for the Project to be implemented on a Public Private Partnership (PPP) basis. The 3<sup>rd</sup> Phase Project, is adjudged by world renowned Consultants and Medical Experts as the single largest tertiary health care related Project in sub-Saharan Africa.

Prince Albert Adedayo Awofisayo has been a visionary, a pioneer, who has, for the past Forty-four (44) years, spent great effort and his precious time on improving tertiary health care delivery in Nigeria, with a view to curbing the growing incidence of medical tourism and brain drain.

Prince Albert Awofisayo sits on the Board of several Companies.

3. Edwin Abubokha, Executive Director, Project Development and Monitoring.


